

In accordance with Student Government Hiring Procedures, found within Chapter 215 of Student Government Statutes, a hiring team shall be formed for the purpose of recommending a suitable candidate to fill the Associate Justice positions. For the purposes of hiring the Director of Community Affairs, the Hiring Team shall consist of:

1. Rhondel Whyte, Student Body Vice-President
2. Greg Berkowitz, Chief of Staff
3. Jerimah Forbes, Chief Financial Officer
4. Jessica Morgan, SGATO Assistant Director

Pursuant to the Student Government Hiring Procedures, Greg Berkowitz shall serve as the Chairman, and shall be responsible for reviewing applications and scheduling interviews with the applicants. Jessica Morgan shall serve as the non-voting member of SGATO. This team shall execute the task of interviewing a minimum of three applicants who are deemed to be the most qualified candidates for the position.

The Hiring Team shall be formed immediately, and make a recommendation to the Student Body President no later than the close of business on Friday, June 27<sup>th</sup>, 2014. The Hiring Team shall be terminated upon the issuing of the final recommendation for appointment.
