**Whereas,** we recognize Mr. Mullis for his accomplishments as President of Trenam Kemker, the law firm of which he founded.



**Whereas,** we acknowledge Mr. Mullis as the recipient of the University of South Florida President's Distinguished Citizen Award in 2007.


**Whereas,** we look forward to the future leadership and stewardship of Mr. Mullis as the University Board of Trustees Chairman.


